# (Cookies and Web Beacons)

# **Log Files**

**Eight-11 Agency** follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and it is a part of hosting services' analytics. The information is collected by log files and that includes internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring and exit pages, and possibly the number of clicks. These are not linked to any personal information that could identify the visitor. The purpose of the information is for analysing trends, administering the site, tracking users' movements on the website, and gathering demographic information.
